The Assignee hereby agrees to bear any reasonable and necessary out-of-pocket fees and costs incurred by the Assignor in connection with the assignment of the Patents.

2 FURTHER ASSURANCE

The Assignor hereby covenants with the Assignee that the Assignor shall, at the expense of the Assignee, execute and sign all such instruments, applications and documents and do all such acts and things as may reasonably be required by the Assignee to enable the Assignee or its nominee to enjoy the full benefit of the rights assigned by this agreement.

3 EFFECTIVE DATE

This Assignment shall come into force on the last date on which it is signed by the parties, which shall be the date inscribed on the title page and at the beginning of this Assignment.

4 GOVERNING LAW AND JURISDICTION

This assignment shall be governed by and construed in accordance with the law of England and the parties hereby submit to the exclusive jurisdiction of the English courts.


