**ASSIGNMENT**

WHEREAS, we, Charles S. WILLIAMS, 2000 Jones Road, Golden, CO, 80403, U.S.A. and John E. 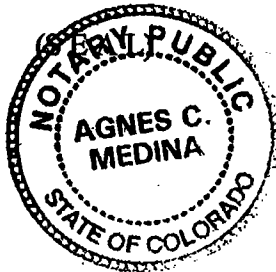

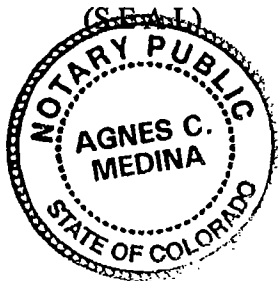
