NOW, THEREFORE, in consideration of the mutual promises, covenants and obligations set forth and for good and valuable consideration, the receipt of which ASSIGNOR acknowledges, ASSIGNOR has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to ASSIGNEE the entire right, title and interest in said applications and said inventions, and in any and all United States Letters Patents that may be granted and issued therefor and all continuations, divisionals, continuations-in-part, reissues and extensions thereof, and all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said inventions in any foreign countries and all patents (including all continuations, divisionals, continuations-in-part, extensions, renewals and reissues thereof) granted for said inventions in any foreign countries; and ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patent registrations, certificates and the like for said inventions to ASSIGNEE in accordance with the terms of this Assignment, the same to be held and enjoyed by ASSIGNEE, its successors and assigns, together with all claims for damages and profits by reason of past, present and future infringement of any rights included in said patents, with the right to sue for and collect the same for its own use and benefit and for the use and benefit of its successors, assigns, and other legal representatives.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement.

ASSIGNOR further covenants that ASSIGNOR will, upon request, promptly provide ASSIGNEE with all pertinent facts and documents relating to said inventions, said applications, and said patents and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said applications, said inventions and said Letters Patent and said equivalents

in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
