ASSIGNORS hereby authorize and request the Commission of Patents and Trademarks to issue all letters patent on said invention to ASSIGNEE.

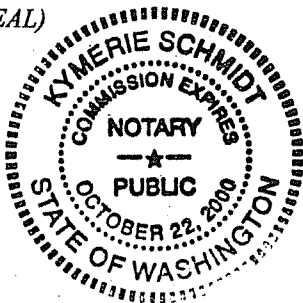
