ASSIGNMENT

AND we HEREBY authorize and request the Commissioner of Patents and Trademarks or any other proper officer or agency of any country to issue all said Letters Patents to said assignee;

AND we HEREBY warrant and covenant that we have full right to convey our entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict herewith;

AND we HEREBY agree to communicate to said assignee or its representatives any facts known to us respecting said inventions, to execute all divisional, continuation, reissue and foreign applications, sign all lawful documents and make all rightful oaths relating to said inventions, and to testify in any judicial or administrative proceeding and generally do everything possible to aid the said assignee to obtain and enforce said Letters Patents in the United States or any foreign country when requested so to do by said assignee.
