CLARIFICATION OF ASSIGNMENT


WHEREAS, I, Michael W. Dickinson, being a citizen of the United States, having an address at 100 Piney Creek Lane, North East, MD 21901, previously assigned the entire right, title, and interest in and to U.S. Patent No. 5,961,389, issued October 5, 1999, to Michael W. Dickinson, Inc. ("Assignee") with its principal place of business in Cecil County, Maryland by virtue of a valid assignment agreement ("Assignment") executed by me on April 8, 2005 and a confirmatory assignment ("Confirmatory Assignment") executed by me on April 27, 2005; and

WHEREAS, the Assignment and Confirmatory Assignment erroneously refer to the Assignee as a Delaware corporation, when in fact no such Delaware corporation actually exists and Michael W. Dickinson, Inc. is and always has been a corporation organized and existing under the law of the State of Maryland;

NOW, THEREFORE, I hereby confirm it was my intent at the time that I executed the Assignment and the Confirmatory Assignment that they convey rights to Michael W. Dickinson, Inc., a Maryland Corporation, and that the inadvertent reference to a non-existent Delaware Corporation was an unintentional error. Accordingly, I would like the Assignment Records of the U.S. Patent and Trademark Office to reflect that the Assignee, Michael W. Dickinson, Inc., is incorporated in Maryland.
