## **ASSIGNMENT**

I hereby authorize and request the Commissioner of Patents and Trademarks to issue said Design Letters Patent to the said **POINTBLANK DESIGN INC.**, the assignee of the entire right, title and interest in and to the same, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Design Letters Patent may be granted as fully and entirely as the same would have been held by me/us had this assignment and sale not been made.

The undersigned hereby grants the firm of Bereskin & Parr (Box 401, 40 King Street West, Toronto, Ontario, Canada M5H 3Y2) the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
