ASSIGNMENT

Whereas, GUSTAVO JAMES MEHAS, an individual, residing at 545 E. McKinley Avenue, Unit B, Sunnyvale, California 94086, SANDEEP AGARWAL, an individual, residing at 40404 La Jolla Court, Fremont, California 94539, JAYANT VIVREKAR, an individual, residing at 1477 Greene Drive, San Jose, California 95129, and XIAOLE CHEN, an individual, residing at 7336 Alexis Manot Place, San Jose, California 95120, ("Applicants"), have invented certain new and useful improvements in a METHOD FOR USING DIGITAL PLL IN A VOLTAGE REGULATOR (the "Invention"), for which United States Patent Application was filed on December 6, 2007 (Serial No. 11/951,565) (the "Application"); and

Applicants further agree to communicate to Assignee, its successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Invention in all countries.
