ASSIGNMENT

WHEREAS, Arunabha Ghosh, a citizen of India, residing at 7011 W. Parmer Lane #1132, Austin, Texas 78729; hereinafter called the "Assignor", have made the invention described in the United States patent application entitled "Delay-Induced Scattering with Phase Randomization and Partitioned Frequency Hopping", Attorney Docket No. 1033-LB1019 (SBC File LB1019), for a full description of which reference is here made to an application for Letters Patent of the United States filed on October 10, 2003, and assigned Application Serial No. 10/683,891; and

Assignor authorizes attorney or agent to fill in the U.S. Application Serial No. above, if required.

AND said Assignor authorizes and requests the Commissioner of Patents to issue Letters Patent on said application, and on any all divisions and continuations thereof, to

said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.
