assigns or other legal representatives, and generally cooperate to the fullest extent in all matters pertaining to said invention, and any and all of said Letters Patent and the title thereto in DIRECTV, its successors, assigns or other legal representatives.

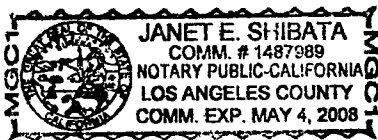


