(GM Global Technology Operations, Inc., Daimler AG, and Chrysler LLC and Bayerische Motoren Werke Aktiengesellschaft, hereinafter jointly referred to as the ASSIGNEES, their respective successors, assigns or other legal representatives), the entire right, title and interest, domestic and foreign, in and to the inventions and discoveries in:

TRANSMISSION PACKAGING AND ROTOR SUPPORT STRUCTURE

ASSIGNOR further agrees to communicate to ASSIGNEES, or their respective representatives, any facts known to it respecting the invention, testify in any legal proceedings relating to the invention when called upon, and sign all instruments and documents and render such assistance which, in the judgment of ASSIGNEES, are necessary to vest in it and protect the legal right, title and interest assigned in this Assignment.

This Assignment will be binding on ASSIGNOR'S successors, assigns or other legal representatives.
