

or their own name, to apply for, obtain and enforce proper patent and/or Utility Model protection for said invention in all countries, all without further consideration but at the expense of said **WESTINGHOUSE ELECTRIC COMPANY LLC**, its successors, assigns, nominees or other legal representatives.
