Patent Assignment

Assignor also hereby covenants and warrants that the patents/patent applications listed in Appendix A to this assignment represents a complete list of the rights to be transferred by this assignment and that these rights are: (i) in good standing, and (ii) free from any liens, encumbrances, security interests, other conveyances.
