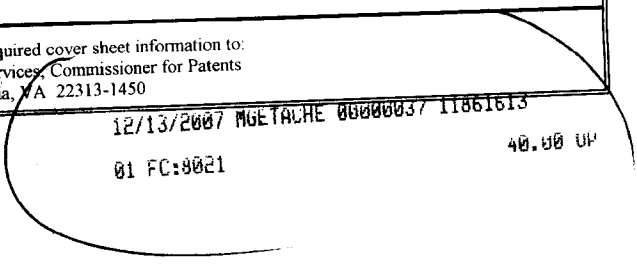

I request that any and all patents for said inventions be issued to Landis+Gyr in the United States and in all countries foreign to the United States, or to such nominees as Landis+Gyr may designate.
