ASSIGNMENT

WHEREAS, WE, MATHIEU LION and LUCAS BIGNON, citizens of France, residing at 9 Cite Aubry, Paris, France 75020 and 60 Rue Etienne Dolet, Cachan, France 94230, have invented a new and useful FIXED-BLADE KNIFE HAVING A MULTI-PURPOSE GUARD, for which application papers for United States Letters Patent was filed on October 19, 2007 and assigned Application Serial No. 11/875,498; and

WHEREAS, MASTRAD, S.A., a corporation organized and existing under and by virtue of the laws of France and having its place of business at 16, rue FranHois Truffaut, Paris, France 75012, is desirous of acquiring the exclusive right, title and interest in and to said invention and in and to the Letters Patent to be granted and issued therefor in the United States of America and its territories and possessions, and all countries foreign thereto:

NOW, THEREFORE, for a valuable consideration, the receipt of which is hereby acknowledged, we, MATHIEU LION and LUCAS BIGNON, do hereby sell, assign, transfer, and set over unto the said MASTRAD, S.A., its successors and assigns, the full and exclusive right, title, and interest in and to the said invention, and in and to any and all Letters Patent to be granted and issued therefor, not only for, to and in the United States of America, its territories and possessions, but for, to and in all other countries including all priority rights under the International Convention; and we hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent to said MASTRAD, S.A., its successors and assigns, in accordance with this Assignment.
