KNOW ALL MEN BY THESE PRESENTS THAT

WHEREAS,

We, Kevin A. Jarrell of Lincoln, MA, Vincent W. Coljee of Cambridge, MA, William Donahue of Quincy, MA, and Svetlana Mikheeva, Lynwood, WA have invented certain improvements in "IMPROVED NUCLEIC ACID CLONING" and


WHEREAS, TRUSTEES OF BOSTON UNIVERSITY, a corporation duly organized under the laws of the Commonwealth of Massachusetts, and having a regular and established place of business at 108 Bay State Road, Boston, County of Suffolk, Commonwealth of Massachusetts, is desirous of acquiring the entire right, title and interest in and to said invention and to any and all Letters Patent of the United States and of all other countries which may be granted therefor; and

WHEREAS, We Kevin A. Jarrell, Vincent W. Coljee, William Donahue, and Svetlana Mikheeva have entered or will enter into an Agreement with the Boston University Medical Center (BUMC), under the terms of which all rights in the aforesaid invention are to be acquired by Trustees of Boston University and net royalties generated by the invention of "IMPROVED NUCLEIC ACID CLONING" and accruing to Trustees of Boston University are to be shared with the inventor(s), the Boston University School of Medicine, and University Hospital, pursuant to said Agreement.

NOW, THEREFORE, BE IT KNOWN THAT FOR and in consideration of one dollar and other valuable consideration paid to me/us by the TRUSTEES OF BOSTON UNIVERSITY, a corporation of Massachusetts, hereinafter called Assignee, having its principal place of business at Boston, Massachusetts, the receipt of which is hereby acknowledged, do hereby sell, assign and transfer unto said Trustees of Boston University, its successors, assigns and legal representatives, the entire right, title and interest for the United States of America and all foreign countries in and to any and all improvements which are disclosed in the application for United States Letters Patent entitled: "IMPROVED NUCLEIC ACID CLONING" invented by us and described in said application executed by me of even date herewith and filed on June 29, 2001, Serial Number 09/897,712 and in and to said application and all divisional, continuing, substitute, renewal, reissue and all other applications for Letters Patent which have been or shall be filed in the United States and all foreign countries on said improvements; and including all rights of priority resulting from the filing of any such applications.

We agree that said Assignee may apply for and receive Letters Patent in its own name; and that when requested, without charge to but at the expense of said Assignee, its successors, assigns and legal representatives to carry out in good faith the intent and purpose of this assignment, the undersigned will execute all divisional, continuing, substitute, renewal, reissue and all other patent applications on any and all said improvements; execute all rightful oaths, assignments, powers of attorney and other papers; communicate to said Assignee, its successors, assigns and legal representatives, all facts known to the undersigned relating to said improvements and the history thereof; and generally do everything possible which said Assignee, its successors, assigns and legal representatives shall consider desirable for aiding in securing and maintaining proper patent protection for said improvements, and for vesting title to said improvements and all application for patents and all patents on said improvements, in said Assignee, its successors, assigns and legal representatives; and I/we do hereby authorize and request the Commissioner of Patents of the United States to issue such Letters Patent as shall be granted upon said U.S. application(s) to said Assignee, its successors and assigns.

We covenant with said Assignee, its successors, assigns and legal representatives that no assignment, grant, mortgage, license or other agreements affecting the rights and property herein conveyed has been made to others by the undersigned, and that full right to convey the same as herein expressed is possessed by the undersigned.

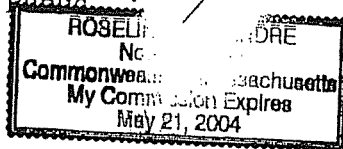
