ASSIGNMENT

WHEREAS We, 1) **Martin Sandal Nielsen of Vadgårdsvej 22, DK-6830 Nørre Nebel, Denmark** and 2) **Bjarne Ravndal Andreassen of Hunsballevej 59, DK-7600 Struer Denmark;** (hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:

cooperate in all matters in connection with the United States and foreign applications and patents issuing thereon.
