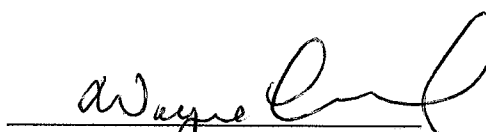

The Commissioner of Patents & Trademarks is hereby authorized and requested to issue said Letters Patent to said GBD Corp., the assignee of the entire right, title and interest in and to the same, for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted, as fully and entirely as the same would have been held by us had this assignment and sale not been made.
