FOR VALUE RECEIVED, We, Wei CUI and Pei LI citizens of Finland and China, and residing at Harakantie 4 C 35 02650 Espoo, Finland, and Puistokaari 7 A4, 00200, Helsinki, Finland, respectively, hereby sell, assign and transfer to **NOKIA CORPORATION**, a corporation duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in a **METHOD AND APPARATUS FOR TRANSFERRING ELECTRICAL POWER IN AN ELECTRONIC DEVICE**, which is described in an application for Letters Patent of the United States, Serial No. 11/977,724 filed October 24, 2007; and all the rights and privileges under any and all Letters Patent that may be granted therefor.


