THIS AGREEMENT is made on 29 NOVEMBER, 2007

BETWEEN

- (1) **STRETCHLINE HOLDINGS LIMITED**, a company incorporated under the laws of Hong Kong (registered number 801597) whose registered office is at 16th to 19th Floors, Princes Building, 10 Chater Road, Central Hong Kong (the "Assignor"); and
- (2) **STRETCHLINE INTELLECTUAL PROPERTIES LIMITED**, a company incorporated under the laws of the British Virgin Islands (registered number 1435092) whose registered office is at Offshore Incorporation Centre, Road Town, Tortola, British Virgin Islands (the "Assignee").

BACKGROUND

- (A) The Assignor is the legal owner of the patents detailed in Part 1 of Schedule 1 (the "Patents") and the patent applications detailed in Part 2 of Schedule 1 (the "Patent Applications").
- (B) The Assignor has agreed to assign the Patents and the Patent Applications to the Assignee on the terms and conditions set out in this Agreement.

OPERATIVE PROVISIONS

1. ASSIGNMENT

- 1.1 In consideration of the payment of £1.00 by the Assignee to the Assignor, receipt of which is hereby acknowledged, the Assignor assigns to the Assignee:
 - 1.1.1 the Assignor's interest in, and right and title to, the Patents and the full and exclusive benefit of each of them;
 - 1.1.2 any patents granted pursuant to the Patent Applications;
 - 1.1.3 all the rights of the Assignor to and in the Patents and the right to be registered as proprietor of the Patents in that country; and
 - 1.1.4 all and any other rights and powers arising or accruing from the Patents and the Patent Applications, including the right to sue for damages and to have the benefit of any other remedies for infringements of the Patents, including infringement of any patents granted under the Patent Applications, occurring before the date of this Agreement.

2. **FURTHER ASSURANCE**

- 2.1 The Assignor agrees at the expense of the Assignee to execute such further documents, and take such actions and do such things, as may be reasonably requested by the Assignee to give full effect to the terms of this Agreement and to secure the full right title and interest of the Assignee in the Patent Applications and the Patents.

3. **MISCELLANEOUS**

- 3.1 The parties to this Agreement do not intend that any of its terms will be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person not a party to it.
- 3.2 The formation, existence, construction, performance, validity and all aspects whatsoever of this Deed or of any term of this Agreement will be governed by the law of England and Wales.
- 3.3 The courts of England and Wales will have non-exclusive jurisdiction to settle any disputes that may arise out of or in connection with this Agreement.




