**ASSIGNMENT**

WHEREAS, WE, Scott J. Brabec, Kenneth C. Gardeski, SuPing Lyu, James A. Coles, Jr. and Christopher M. Hobot, are the inventors of MEDICAL DEVICES INCORPORATING CARBON NANOTUBE MATERIAL AND METHODS OF FABRICATING SAME, for which an application for a United States Patent was filed on January 20, 2005, under Serial No. 11/038,731; and





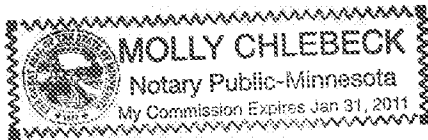
