And I request the Commissioner of Patents to issue any Letters Patent of the United States which may be issued for said inventions to said AGFA-GEVAERT, its legal representatives, successors or assigns as the sole owner of the entire right, title and interest in and to said patent and in the United States in and to the invention covered thereby.
