(b) all of the Grantor's Patent Collateral with respect to the Patents referred to on Schedule II hereto; and

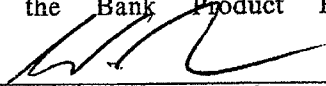
(c) all of its Trademark Collateral with respect to the Trademarks referred to on Schedule III hereto.

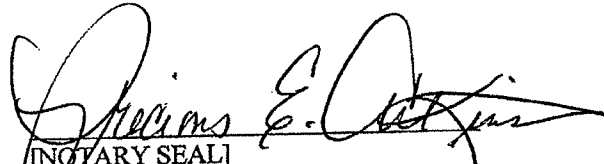
