

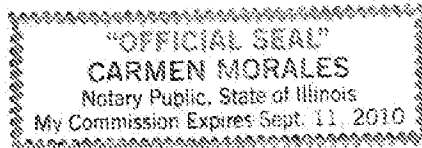

- (a) All inventory, Seller's WIP (defined below) and finished product, as of the Closing Date, including but not limited to those items listed on **Schedule 1(a)**;
- (b) All production equipment, furniture, and office equipment, including but not limited to the items listed on **Schedule 1(b)**;
- (c) All customer lists, customer information, and billing information, including but not limited to the list of customers attached as **Schedule 1(c)**;
- (d) All office supplies, tooling, samples, and art work;
- (e) All sales and marketing materials;
- (f) All supplier and vendor contracts, vendor lists and associated records, including but not limited to those listed on **Schedule 1(f)**;
- (g) All pending purchase orders and active customer contracts, including but not limited to those listed on **Schedule 1(g)**;
- (h) All of Seller's rights in the d/b/a "**Compton Presentation Systems**";
- (i) Seller's website and the *comptonline.com* domain name and URL address;
- (j) Except as provided on **Schedule 1(j)**, all of Seller's telephone listings and telephone numbers including the number 800-336-4940 and the fax number 630-539-2209; and
- (k) All of Seller's trade secrets and intellectual property, including but not limited to Seller's patents, pending patent applications, and trade names listed on **Schedule 1(k)**, except for the Unimax Article Patent which Seller does not own.

Capitalized terms used herein without definition shall have the meanings given such terms in the Asset Purchase Agreement. Nothing contained herein shall be deemed to alter, modify, expand or diminish the terms and provisions set forth in said Asset Purchase Agreement, including the representations, warranties and covenants concerning the assets conveyed thereunder. Executed facsimile transmissions of this Agreement shall be deemed originals and shall be fully enforceable.

This Bill of Sale shall be binding upon Seller and its successors and assigns and shall issue to the benefit of Buyer and its successors and assigns.

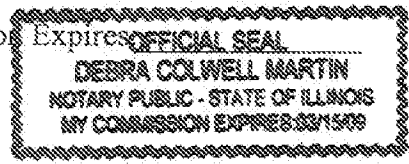
