**ASSIGNMENT**



**AND** for the same consideration, Dickinson hereby covenants and agrees to and with Eggs Overnight that, at the time of execution and delivery to Eggs Overnight of these presents, Dickinson is the sole and lawful owner of the entire right, title and interest throughout the world in and to U.S. Patent No. 7,155,854 and any and all patent applications derived therefrom, that the same are unencumbered and that Dickinson has good and full right and lawful authority to sell and convey the same in the manner herein set forth.



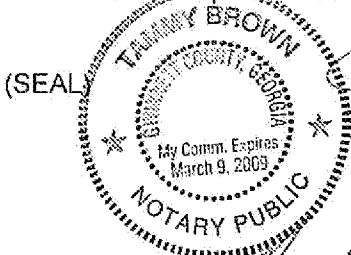
