
2. Said Inventor hereby covenants and agrees to cooperate

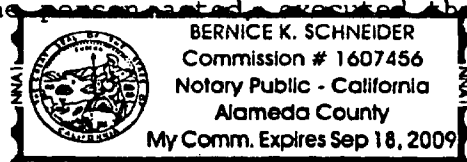
