ASSIGNMENT OF INVENTION

WHEREAS, we, **John K. Roma**, residing at 30 Kingswood Drive, Orchard Park, NY 14127 and **Paul J. Morgante, Jr.**, residing at 226 Curtis Parkway, Kenmore, NY 14223, have invented a certain new and useful improvement in an "Automatic Futon Frame" for which an application for Letters Patent in the United States was executed on the date which appears next to our signatures.

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to us in hand paid, the receipt of which is hereby acknowledged, we hereby assign, sell, and transfer unto said Otis Bed Manufacturing Company, Inc. the entire right, title, and interest in said invention, said application, and in and to any and all Letters Patent of the United States, and countries foreign thereto, which may be granted for said invention, and in and to any and all priority rights, rights under the International Convention For The Protection Of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to us with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto.


