ASSIGNMENT

This Assignment is made and entered into by and between **(1) Chansol Chung**, residing at 6000 Nob Hill Dr., Apt. 312, Chagrin Falls, Ohio 44022, **(2) Anthony J. 2. IDEASTREAM is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of IDEASTREAM or otherwise as IDEASTREAM may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to IDEASTREAM in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTORS, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.

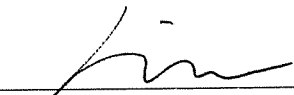
