successors, assigns, and legal representatives, deemed essential to ASSIGNEE'S full protection and title in and to the invention hereby transferred and for maintaining any resulting patent concerning said invention.

By accepting this Assignment, ASSIGNEE agrees to defend and hold harmless ASSIGNOR from any claims or liabilities arising from ASSIGNEE'S use of the Patent and development of any products thereunder.


