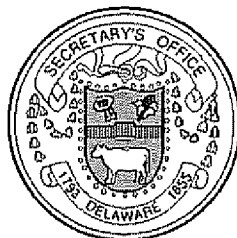

1. He is the duly elected and acting President of Mixxer, Inc., a corporation organized and existing under the laws of the state of Delaware (the "Corporation").
2. The name of the Corporation is Mixxer, Inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on November 10, 2005, in the name of 3GUpload Acquisition Corp. The Certificate of Incorporation was amended on November 17, 2005 and December 20, 2005. The Certificate of Incorporation was restated on February 16, 2006. The Restated Certificate of Incorporation was amended on May 12, 2006.
3. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment of the Restated Certificate of Incorporation further amends the provisions of the Corporation's Restated Certificate of Incorporation.
4. The terms and provisions of this Certificate of Amendment of the Restated Certificate of Incorporation have been duly approved by written consent of the required number of shares of outstanding stock of the Corporation pursuant to Subsection 228(a) of the General Corporation Law of the State and written notice pursuant to Subsection 228(e) of the General Corporation Law of the State has been or will be given to those stockholders whose written consent has not been obtained.
5. Article I of the Restated Certificate of Incorporation is hereby amended to read in its entirety as follows:

**"ARTICLE I: NAME**

The name of the corporation is 3Guppies, Inc."
