## ASSIGNMENT

WHEREAS WE, VIATCHESLAV V. KOVTOUN of 444 Saratoga Avenue, Apt. 13J, Santa Clara, California 95050; and ALEXANDER ALEKSEEVICH MAKAROV of 90 Marlborough Avenue, Cheadle Hulme, Cheshire, SK8 7AR United Kingdom, have invented certain new and useful improvements, entitled **MASS SPECTROMETER WITH LOOPED ION PATH** for which invention we have executed an application for Letters Patent in the United States that was filed on 01/11/2008 with the U.S. Patent and Trademark Office as Serial No. 12/013,352 which discloses and identifies the invention.

Upon said consideration, we convey to said assignee the right to make application in its own behalf for protection of said invention in countries foreign to the United States and where expedient to claim under the International Convention or other international arrangement for any such application the date of said United States application (or other application if any there be) in priority to other applications; and we do hereby covenant and agree with the said assignee that we will not execute any writing or do any act whatsoever conflicting with these presents, and that we will at any time upon request, at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, renewal, continuation, continuation-in-part, reissued or extended Letters Patent of the United States or of any and all foreign countries on said invention, and in enforcing any rights or chose in action accruing as a result of such application or patents, by giving testimony in any proceedings or transactions involving such application or patents, and by executing

preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of both parties.

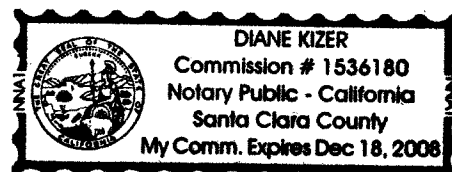
