

AND I request the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for said inventions to said TELESTEPS AB, its legal representatives, successors or assigns, as the sole owner of the entire right, title, and interest in and to said patent and in the United States and in and to the invention covered thereby.
