ASSIGNMENT

WHEREAS, we, DEAN L. MEHLER of Wichita, Kansas, and JAMES WIEBE of Wichita, Kansas, have invented certain improvements in UNINTERRUPTIBLE A/C POWER SUPPLY TRANSFER UNIT, for which we filed United States Provisional Patent Application Serial Number 60/897,292 on January 25, 2007, and for which we are filing a PCT patent application on January 25, 2008; and

Further, we hereby covenant and agree to and with CRU Acquisition Group, LLC, and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified PCT patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, we agree that we will communicate to CRU Acquisition Group, LLC, or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to CRU Acquisition Group, LLC, make all rightful oaths, and generally do everything possible to aid CRU Acquisition Group, LLC, and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.


