

Assignors hereby covenant that no assignment, sale, agreement or encumbrance has been, or will be, made or entered into which would conflict with this Agreement and sale.



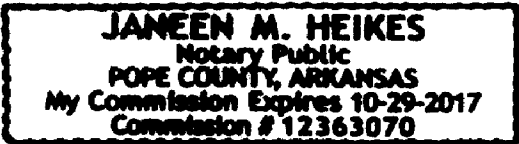
