RELEASE

This Release, dated as of January 31, 2008 (the "Release"), is made by Silicon Valley Bank, as secured party (the "Secured Party"), in favor of eScreen Inc., a Delaware corporation (formerly a Kansas corporation) ("Grantor") and its subsidiaries and affiliates, including ESP Employment Screening Partners, Inc. (and formerly including eScreen Holdings, Inc. and eScreen General Partnership) (jointly, "eScreen").

WITNESSETH

WHEREAS, the Grantor and the Secured Party previously entered into that certain Loan and Security Agreement, including amendments thereto, executed January 28, 2004 (as amended, the "Loan and Security Agreement"). The Grantor and Secured Party also entered into that certain Intellectual Property Security Agreement executed January 28, 2004 (the "IP Agreement") and recorded with the United States Patent and Trademark Office on 07/07/04 at Reel/Frame Number 015460/0429 with respect to the patents, and on 06/08/04 at Reel/Frame Number 2986/0788 with respect to trademarks, pursuant to which the Secured Party has been granted a security interest in, among other things, Grantor's Intellectual Property (as defined in the Loan and Security Agreement), including the intellectual property of Grantor listed in the attached Exhibit A and Exhibit B.

WHEREAS, the Secured Party acknowledges that full payment, complete performance and satisfaction of all obligations pursuant to the Loan and Security Agreement secured by the intellectual property have been made; and

WHEREAS, the Grantor has requested and the Secured Party agrees to release its security interest in the Grantor's Intellectual Property in connection with the termination of the Loan and Security Agreement and the IP Agreement;

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases, without recourse, all of its security interest, liens, assignment, and other interest in and to the Grantor's Intellectual Property, including such property listed on Exhibit A and Exhibit B attached hereto and incorporated herein by reference, and any other Grantor's Intellectual Property under, and as defined in, the Loan and Security Agreement or IP Agreement (the "Released Collateral").

The Secured Party agrees to provide, at no expense to the Secured Party (any expense incurred by the Secured Party is to be paid by the Grantor), the Grantor with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.


