WHEREAS, Assignee is desirous of acquiring said patent; and



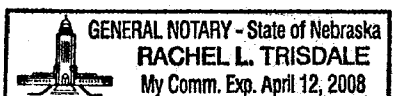



