ASSIGNMENT

WHEREAS, We, **JOHN R. BLAKE, GARY W. COOPER, PATRICK J. FINN, MARK C. MUNRO** and **MARK A. FLADELAND**, have invented certain new and useful improvements in the following: **COIN PROCESSING SYSTEM HAVING MOVEABLE COIN RECEPTACLE STATION**, for which we have made application for United States Letters Patent; and,

We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.


