Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary or appropriate to perfect such rights, title and interest assigned hereby in Assignee, his successors, assigns and legal representatives.

In furtherance of the foregoing, Assignor hereby grants to Assignee an irrevocable power of attorney, with full power of substitution and delegation, to execute and file all applications, assignments, declarations, affidavits, and any other papers in order to effectuate the transactions and assignment herein made and to further evidence and protect such assignment and to assure the proper assignment of the Patent to Assignee, in Assignor's name, place and stead, just as fully as might Assignor, and to sign and file all lawful papers, execute and file all provisional, divisional, continuation, continuation in part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title to the Patent in Assignee.
