# PATENT AND DESIGN ASSIGNMENT AGREEMENT

THIS ASSIGNMENT is made and entered April 4, 2007 (the "Effective Date"), by and among WRIGHT MEDICAL TECHNOLOGY, INC., a Delaware corporation with its principal place of business at 6677 Airline Road, Arlington, Tennessee 38002 U.S.A. 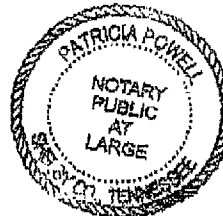
