reissues, extension, and the like of said applications and patents and like grants, including without limitation, those obtained or permissible under past, present and future laws or statutes;

3. The right to file in its name applications for patents and like protection for said Inventions in any country or countries foreign to the United States; and

4. All international rights or priority associated with said Inventions, applications for patents, patents and like protection.

Assignor hereby authorize and request the Director of U.S. Patent and Trademark Office, and all other national patent offices in which corresponding applications are filed, to issue any patents for the said Inventions to said assignee, of the entire right, title, and interest in and to the same, for his sole use and behoof and for the use and behoof of his legal representatives, to the full end of the term for which said patent may be granted, as fully and entirely as the same would have been held by me had this assignment and sale not been made.
