ASSIGNMENT OF PATENT APPLICATION BY CORPORATION

For good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned Carl-Zeiss-Stiftung trading as Carl Zeiss, a German corporation having a place of business at D-89518 Heidenheim (Brenz), Federal Republic of Germany, ("Assignor") does hereby:

- (a) represent and warrant that Assignor is the owner of an undivided interest in the invention and corresponding utility patent application entitled **SYSTEM AND METHOD FOR DETERMINING A POSITION OR/AND ORIENTATION OF TWO OBJECTS RELATIVE TO EACH OTHER AS WELL AS BEAM GUIDING ARRANGEMENT, INTERFEROMETER ARRANGEMENT AND DEVICE FOR CHANGING AN OPTICAL PATH LENGTH FOR USE IN SUCH A SYSTEM AND METHOD**, filed in the U.S. Patent and Trademark Office on April 10, 2002, having serial number 10/120,253 ("the '253 Application");

- (c) agree, upon request by and at the expense of Assignee (or its successors, assigns or legal representatives), to: (i) execute all other lawful papers necessary or desirable to secure Assignee's title in the property conveyed herein; and (ii) otherwise fully cooperate with Assignee in connection with perfecting Assignee's title, or securing, maintaining and enforcing Assignee's rights, under this assignment; and
- (d) represent, warrant and covenant that no assignment, grant, mortgage, license or other agreement inconsistent with the rights and property herein conveyed to Assignee has been made or shall be made by Assignor.
