I hereby request that said Letters Patent be issued in accordance with this assignment.

I further covenant and agree that, at the time of the execution and delivery of these presents; I possess full title to the design and application above-mentioned, and that I have the unencumbered right and authority to make this assignment.

I further covenant, and agree to bind my heirs, legal representatives, and assigns, promptly to communicate to said assignee or its representatives any facts known to me relating to said design, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the assignee, its

representatives, successors, or assigns to secure patent or similar protection for the said design in all countries and to vest in the assignee complete title to the said design and Letters Patent, without further compensation, but at the expense of said assignee, its successors, assigns, and other legal representatives.
