ASSIGNOR also hereby sells and assigns to ASSIGNEE, his successors, assigns, and legal representatives the full and exclusive rights, title, and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models, and designs for said invention in his own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention, and all rights to register said invention in appropriate registries; and ASSIGNOR further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interest in ASSIGNEE, his successors, assigns, and legal representatives.

ASSIGNOR hereby further agrees that it will communicate to ASSIGNEE, or to his successors, assigns, and legal representatives, any facts known to it respecting any improvements; and, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE, his

successors, assigns, and legal representatives to obtain and enforce proper protection for said invention in all countries.

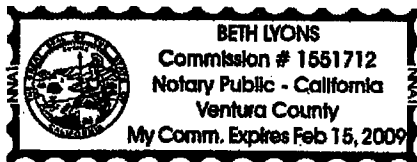
