Restriction on Sale, Transfer or License of Patent Rights

Pursuant to the Exclusive Purchase Agreement entered into as of January 24, 2008 between Continental Materials, Inc., a Pennsylvania corporation ("CMI"), Roof Odor Solutions Inc., an Arizona corporation ("ROS"), A.J. Ronyak and certain other signatories thereto (the "Exclusive Purchase Agreement"), A.J. Ronyak and ROS have granted to CMI the following rights, as such rights are set forth in Section 10 of the Exclusive Purchase Agreement:

"10. Restriction on Sale, Transfer or License of Patent Rights.

a. Each of A.J. Ronyak and ROS hereby covenants and agrees that he or it shall not through action or inaction, cause or allow the transfer, sale, pledge, grant of a security interest in, or license of his or its respective interests in or to US Patent #6,987,207 to any other person or entity without the prior written consent of CMI.

b. ROS and A.J. Ronyak each hereby irrevocably authorizes CMI as its respective true and lawful attorney in fact at any time to prepare and file such documents with the United States Patent and Trademark Office as appropriate to evidence CMI's rights and ROS' and A.J. Ronyak's respective obligations as set forth under Section 10(a)."
