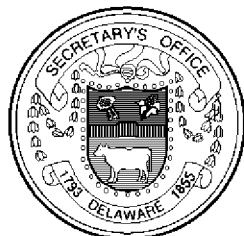

2. The date on which the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of Delaware is May 28, 1997.
3. The Board of Directors of the Corporation, acting in accordance with the provisions of Sections 141 and 242 of the Delaware General Corporation Law, adopted resolutions amending its Certificate of Incorporation as follows:

Articles I and II of the Fifth Amended and Restated Certificate of Incorporation of the Corporation are hereby amended as follows:
