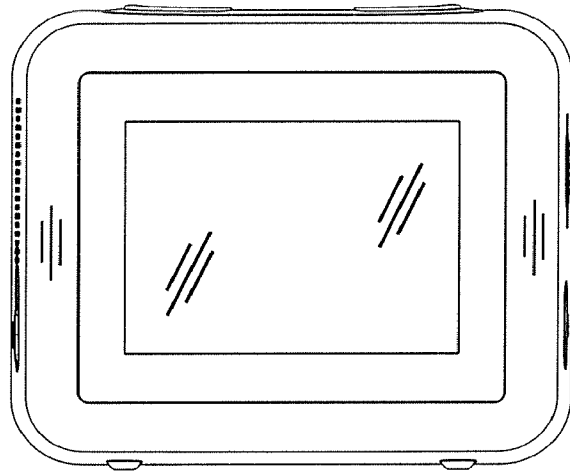

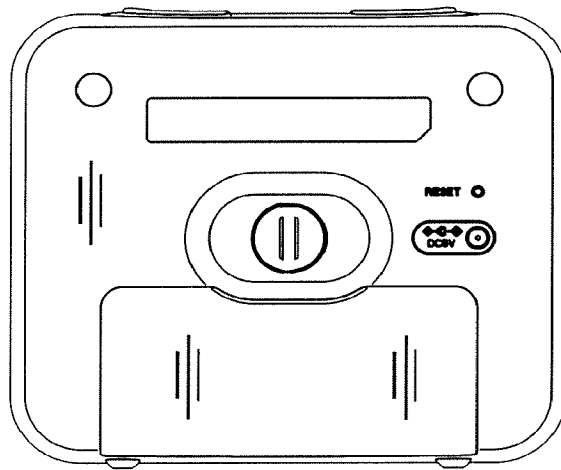

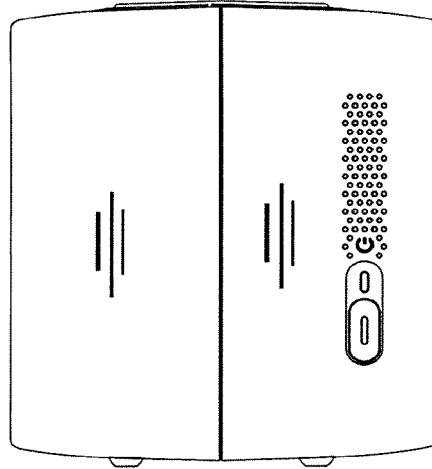

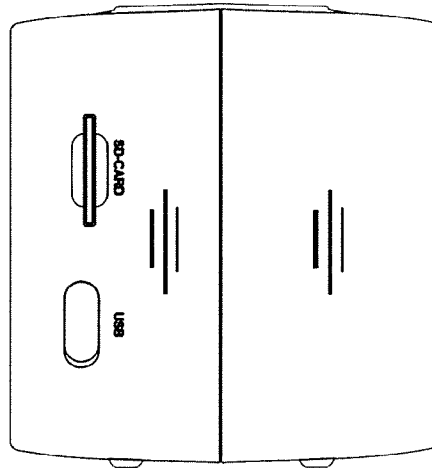

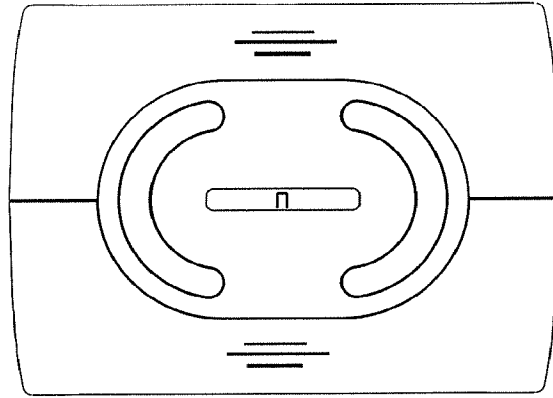

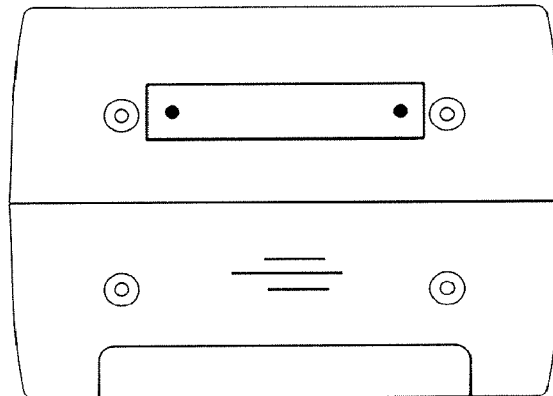

and

(2) SHENZHEN ACT INDUSTRIAL CO., LTD., a limited liability company incorporated under the laws of the People's Republic of China of 1<sup>ST</sup>-3<sup>RD</sup>, 5<sup>TH</sup>-8<sup>TH</sup> FLOORS, NO. 5 BUILDING, YANTIAN BEISHAN INDUSTRIAL PARK, BEISHAN MAIN ROAD, YANTIAN DISTRICT, PEOPLE'S REPUBLIC OF CHINA ("The Assignee")

WHEREAS

- (A) The Assignors created a design for a digital photo frame with coin bank ("the Design"). Representations of the Design are annexed hereto in Attachment A.

- 2. This Assignment shall be governed by and construed in accordance with the laws of the People's Republic of China and the parties hereby submit to the non-exclusive jurisdiction of the courts of the People's Republic of China.
