ASSIGNMENT

WHEREAS, I, Douglas A. Meece, a citizen of the United States, residing at 6612 Cresthaven Street, West Chester, County of Butler, and State of Ohio 45069 (hereinafter referred to as "ASSIGNOR"), have invented a PURGE AND TRAP CONCENTRATOR WITH SPARGE VESSEL, for which I have executed an application for Letters Patent of the United States, of even date herewith, and

ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNOR HEREBY grants the firm of Taylor & Aust, P.C. the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

ASSIGNOR HEREBY covenants and agrees that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.




