SPECIFICATION AND CLAIM OF DESIGN PATENT APPLICATION

Be it known that John Crawford, Donwoong Kang, Todd B. Abernethy, and Scott W. Osiecki have invented a new, original and ornamental design for a LIGHTING DEVICE of which the following is a specification, reference being had to the accompanying drawings, forming a part hereof.

A description of the figures is as follows:

FIG. 1 is a front perspective view of a lighting device, showing our new design;

FIG. 2 is a side plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a side plan view thereof;

FIG. 8 is a side plan view of a lighting device, showing an alternate embodiment of our new design without a clipping device.

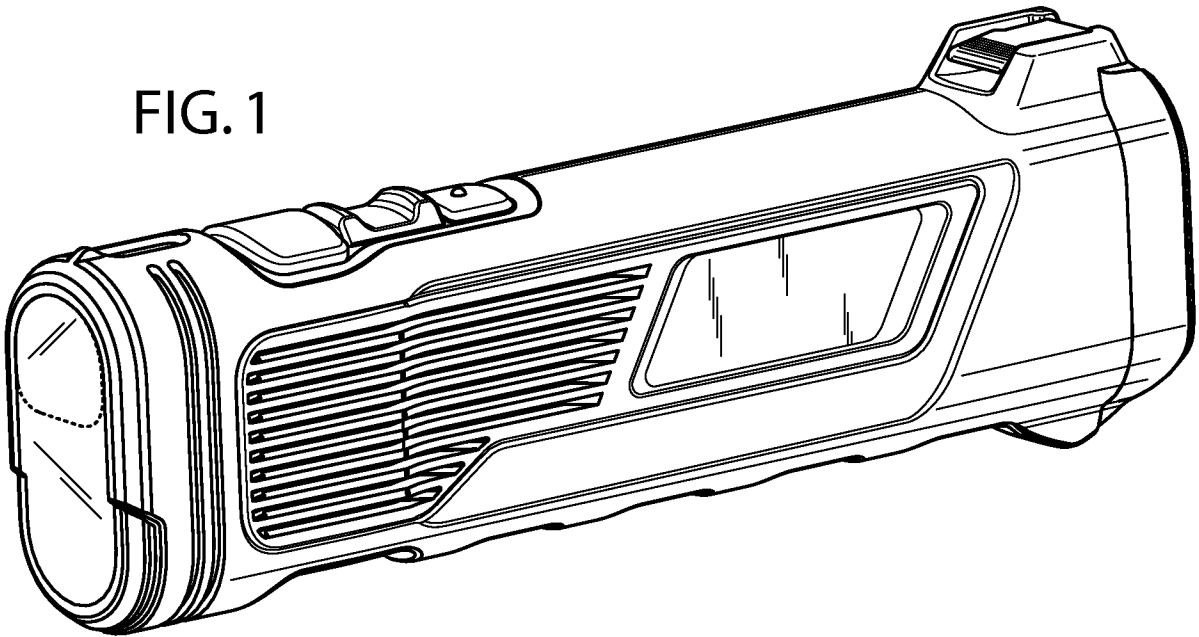

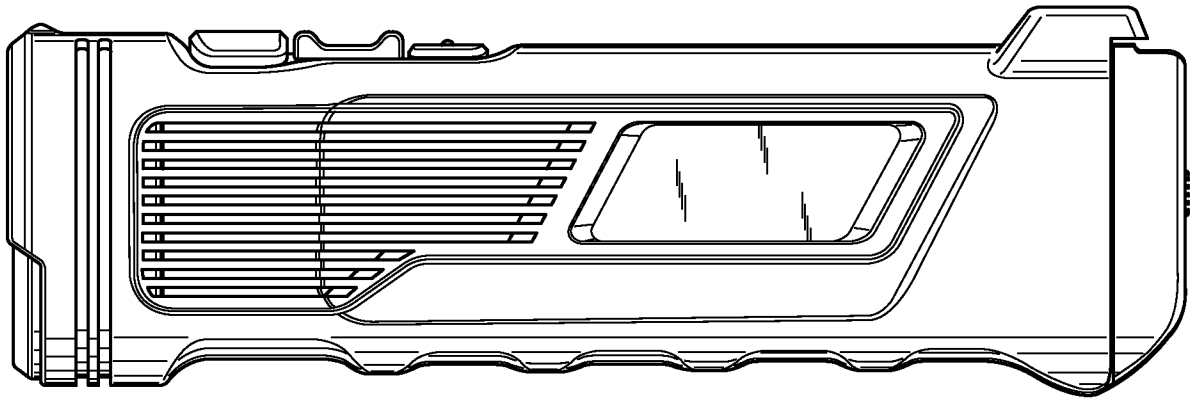

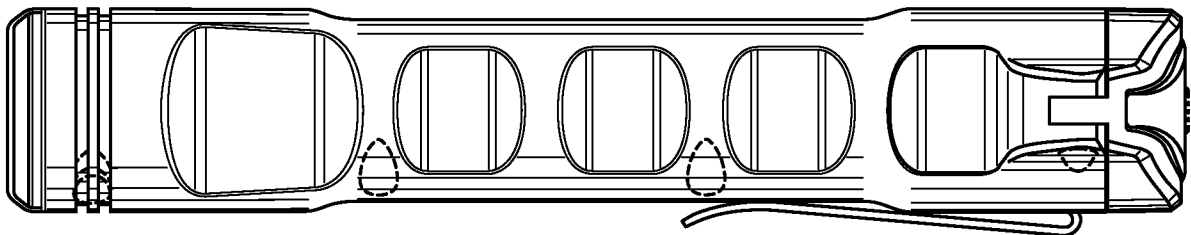

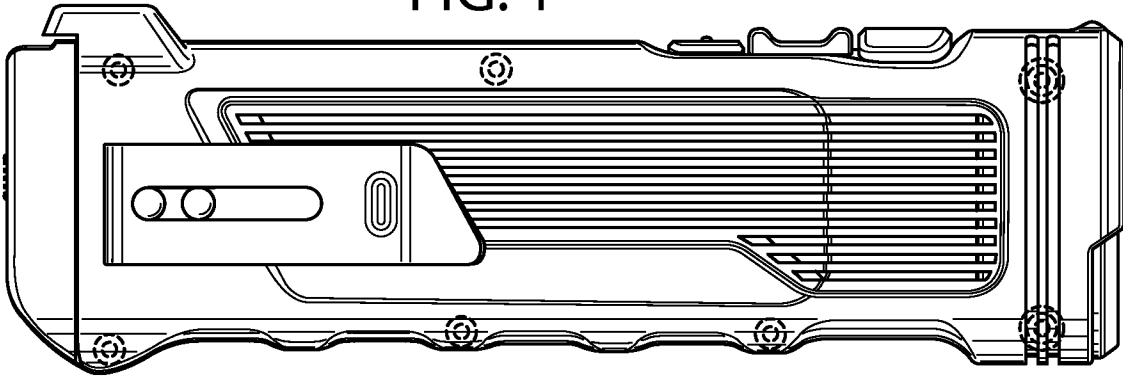

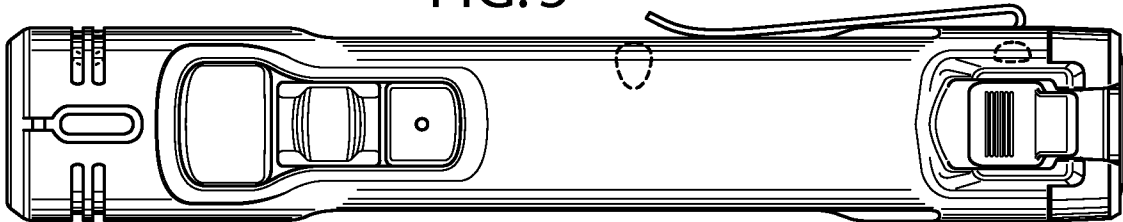

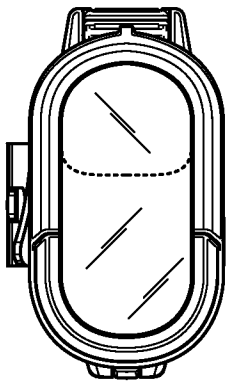

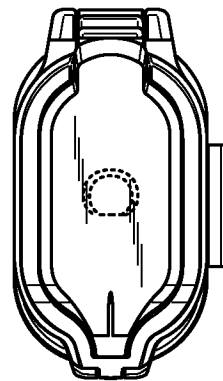
