1. Communicate to said Assignee any facts relating to the invention and the history thereof;

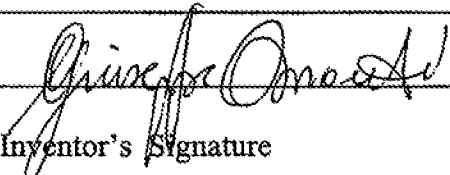

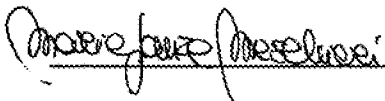
