FIRST: The name of the corporation is Coleman Safety & Security Products, Inc. (the "Corporation").

SECOND: Pursuant to a written consent of the Board of Directors of the Corporation, resolutions were duly adopted setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring the amendment to be advisable, and directing that said amendment be considered at a special meeting of the stockholders of the Corporation entitled to vote thereat called for such purpose. "The name of the corporation is the Maple Chase Company."

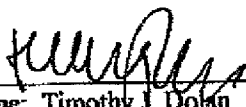
THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the DGCL.
